Introduction

In this report, BW Research Partnership (BW Research) analyzes the data from the DoorDash, Instacart, Lyft, and Uber (including Uber Eats) platforms¹ to determine the volume and distribution of app-based rideshare and delivery activity throughout Massachusetts. Our analysis includes data on rideshare drop-offs and deliveries disaggregated to the regional level. In addition, the report provides top destinations in each area, merchant delivery account information, and rides and deliveries into lower-income areas.

Methodology

Company data were provided by DoorDash, Instacart, Lyft, and Uber for each quarter of 2021 (Uber provided separate data for its Uber Rides and Uber Eats platforms). BW Research had independent access to these data and full discretion in analyzing the provided data. BW Research worked with each company to establish uniform data definitions for purposes of this report.

Public data from the Transportation Network Company (TNC) Division of the Massachusetts Department of Public Utilities "2021 Rideshare Data Report" for pickups and drop offs were used for the data on rides in the state and can be retrieved from https://mass.gov.

Data was broken out geographically using New England City or Town Areas ("NECTAs"), defined by the U.S. Census Bureau as metropolitan and micropolitan statistical areas consisting of an urban core and surrounding municipalities having a high degree of social and economic integration with that core.²

BW Research analyzed ten total areas including eight standalone NECTA regions and two combined areas. The two combined areas are the Worcester, MA-CT area and the Cape and Islands. The Worcester, MA-CT area includes the Worcester, MA-CT NECTA, and the Athol, MA NECTA, while the Cape and Islands area includes Barnstable Town, MA NECTA, Vineyard Haven, MA NECTA, and the town of Nantucket. As defined by the federal government, four of the ten NECTAs contain cities or towns in contiguous areas of New Hampshire, Rhode Island, or Connecticut, but we exclude these non-Massachusetts municipalities from this analysis. A complete listing of Massachusetts municipalities included in each NECTA can be found in the Regional Profiles section of this report.

Use in lower-income areas consisted of rides and deliveries that ended in U.S. Department of Housing and Urban Development (HUD) designated "Qualified Census Tracts" (QCTs).³

Executive Summary

Massachusetts consumers and businesses used app-based rideshare or delivery platforms to connect with independent rideshare and delivery drivers 84.9 million times in 2021, which is an average of more than 232,000 uses a day. The 84.9 million total reflects 39.5 million rides and 45.5 million deliveries completed in Massachusetts in 2021, per platform data from DoorDash, Instacart, Lyft, and Uber.

- Destinations in Greater Boston (defined as the Boston-Cambridge-Newton, MA-NH NECTA, which contains about two-thirds of Massachusetts' population), accounted for 85.0% of all rides and deliveries in 2021, with the balance of rides and deliveries spread across the state.
- Greater Springfield (Springfield, MA-CT NECTA) had the second largest share of rides and deliveries, with 4.2% of the state's total, followed by Greater Worcester (Worcester, MA-CT NECTA), the Fall River and Attleboro area (the portion of the Providence-Warwick, RI-MA NECTA that is in Massachusetts), and the Cape and Islands (Barnstable Town NECTA, Vineyard Haven NECTA, and Nantucket).

The top five most popular destinations for rideshare rides in Greater Boston were Logan Airport, South Station, TD Garden, Encore Boston Harbor casino, and Massachusetts General Hospital. Top destinations in other NECTAs around the state were commonly transportation hubs, such as the airport and ferry terminals in Hyannis, large retail establishments, like Holyoke Mall in Holyoke or Walmart in Lunenburg, educational institutions such as College of the Holy Cross and Quinsigamond Community College in Worcester, health care facilities and various hospitality establishments.

Thousands of Massachusetts restaurants and retailers partnered with one or more of the delivery platforms to enable the restaurants and retailers to provide nearly \$1.5 billion worth of meals, groceries, or convenience items to local consumers. Specifically, Massachusetts businesses maintained approximately 21,000 merchant accounts on DoorDash, Instacart, and/or Uber Eats, and realized total revenues of approximately \$1.46 billion in 2021. We define a "merchant account" as a restaurant, store, or other merchant location that consumers can access via one of these platforms.

 About 76.3% of all merchant accounts on the delivery platforms were located in Greater Boston. Businesses in Greater Worcester, Greater Springfield, the Fall River and Attleboro area, the New Bedford area (New Bedford NECTA), the Cape and Islands area, and the Leominster-Gardner area each had at least 300 and as many as 1,300 merchant accounts on the platforms.

Data in Detail

Regional Definitions

Table 1, below, enumerates the ten total areas we analyzed, including eight NECTA regions and two combined NECTA areas. For the remainder of this report, the NECTAs will be referred to by their common name in narrative portions and by their NECTA name (or combined NECTA name) in tables.

Greater Boston had a population in 2020 of 4.7 million, accounting for 66.4% of the state's total population of approximately 7.0 million. Greater Worcester and Greater Springfield each made up 9.1% of the state's population. The Fall River and Attleboro area accounted for 4.1% of the state's population. The remaining six areas accounted for 10.9% of the state's population.

Services Provided by Drivers to Consumers Via Rideshare and Delivery Platforms

Total Rides and Deliveries

Key Findings

- App-based drivers using the DoorDash, Instacart, Lyft, and Uber platforms provided a total of 84.9 million rides and deliveries to destinations in Massachusetts in 2021.
- 72.2 million rides and deliveries in 2021 occurred in Greater Boston, which was 85.0% of all rides and deliveries statewide.
- Greater Springfield and Greater Worcester were the second- and third-largest destinations for rides and deliveries in 2021, with about 3.6 and 3.5 million rides and deliveries, respectively.
- Even the two smallest areas examined, the Greenfield area and the North Adams area, each accounted for tens of thousands of rides and deliveries in 2021.

Use of Rideshare and Delivery Platforms in Lower-Income Areas

Delivery and rideshare platforms can play an important role in connecting consumers with independent workers for affordable, reliable access to transportation and access to grocery and various food options, particularly in underserved areas. To better understand how rideshare and delivery platforms are used in lower-income areas throughout the Commonwealth, we analyzed the frequency with which Massachusetts rideshare rides and deliveries in 2021 ended in HUD determined QCTs. HUD uses QCTs to determine a location's eligibility for the federal Low-Income Housing Tax Credit. While this method offers important insights, QCTs may include people at a variety of income levels. Thus, findings presented here pertain to use within these areas and should not be equated to use that is solely by low-income persons or households. See the methodology section for a fuller discussion of how QCTs are defined.

Overall, 311 of Massachusetts' 1,620 census tracts, or 19.2%, are designated as QCTs under the definition used in this report.

Key Findings

- 24.3 million rides or deliveries in 2021 ended in lower-income areas (i.e., low-income census tracts) in Massachusetts. Statewide, 28.7% of all rides or deliveries in 2021 ended in, or were delivered to, a lower-income area.
- The share of Greater Boston rides and deliveries ending in low-income areas was 28.8%.
- The New Bedford area, Greater Worcester and Greater Springfield had the highest shares of deliveries that ended in low-income areas, at 36.6%, 34.7% and 30.7%, respectively.

Consumers' Use of Rideshare Platforms

Number of Rides

Key Findings

- App-based drivers using the Lyft and Uber platforms provided a total of 39.4 million rides in the state in 2021
- 36.2 million rides, or 91.9% of all rides statewide, were to destinations somewhere in Greater Boston.
- Greater Worcester and the Cape and Islands area had the second and third highest number of rides in 2021, with 1.0 million and 796,000, respectively.

Top Destinations on Rideshare Platforms

The top five most popular destinations for rideshare rides in Greater Boston were Logan Airport, South Station, TD Garden, Encore Boston Harbor casino, and Massachusetts General Hospital's main Boston campus. Major entertainment venue Fenway Park and leading retail/office location Prudential Center, along with another hospital and two large hotels comprised the balance of the top ten destinations in the region. (See Table 5)

Leading destinations in other NECTAs around the state reflected similar patterns. Transportation hubs - such as Worcester's Union Station, Berkshire County's airports, and Cape Cod's ferry terminals - were at or near the top in most places. Educational institutions, like Fitchburg State College and UMass Dartmouth, and hospitals such as Bay State Medical Center in Springfield appeared on most lists. Shopping spots like Walmart and local malls, along with hospitality and entertainment establishments such as Stockbridge's Red Lion Inn and Six Flags New England in Agawam accounted for most of the remaining destinations.

Merchants' Use and Revenues on Delivery Platforms

Merchant Accounts

App-based delivery platforms such as DoorDash, Instacart, or Uber Eats provide consumers access to deliveries of goods from restaurants, grocery stores, retailers, and other businesses. We define a "merchant account" as a restaurant, store or other merchant location that consumers can access via one of these platforms. As such, the number of merchant accounts may include duplicates as a business can be available on multiple platforms.

Key Findings

- There were approximately 21,000 Massachusetts merchant accounts on the DoorDash, Instacart and Uber Eats platforms in 2021.
- About 18,600 merchant accounts were for establishments located somewhere in Greater Boston, which was 73.6% of the statewide total.
- Greater Springfield and Greater Worcester had the second- and third-largest number of merchant accounts, at approximately 1,300 accounts each.

Merchant Revenues

Key Findings


- Merchant revenues derived from accounts on the DoorDash, Instacart, and Uber Eats platforms totaled \$1.5 billion in 2021.
- 2021 merchant revenues in Greater Boston totaled \$1.1 billion.
- Greater Springfield had the second-largest 2021 merchant revenues at \$99.9 million, followed by Greater Worcester at \$92.1 million.
- 2021 merchant revenues for the Cape and Islands area, the Fall River and Attleboro area, and the New Bedford area were in the tens of millions of dollars each.
- Even the two smallest areas examined, the Greenfield area and the North Adams area, had 2021 merchant revenues in millions of dollars.
